

2017-18 Liability Terms and Conditions

I expressly consent (we expressly consent to allow our son/daughter/ward) to participate in Uxbridge Ski & Snowboard Club (USSC). I/we understand that the sports of skiing, snowboarding and other recreational activities involve inherent and other risks of Injury and Death. In consideration for being permitted to participate in USSC, I/we voluntarily agree to expressly ASSUME ALL RISKS OF INJURY AND DEATH that may result from skiing, snowboarding, or other recreational activities while with the USSC. I/we hereby agree to RELEASE AND HOLD HARMLESS all contributors to USSC, its officers, directors, coordinators, volunteers, chaperones (collectively "PROVIDERS") from ALL LIABILITY for injury, death, property loss and any damages that may result from participation in USSC. This includes, but is NOT LIMITED to, those damages that arise from the sports of skiing or snowboarding. This release is intended to cover any and all activities of USSC, including any and all liability which results from the negligence or gross negligence of the PROVIDERS.

I/WE further agree to DEFEND AND INDEMNIFY the PROVIDERS for any claims or lawsuits arising out of personal injury, death, property loss, or any other damages to any person, caused by, related to or arising out of my (my son's/daughter's/ward's) participation in USSC.

I/WE further agree to RELEASE AND HOLD HARMLESS the PROVIDERS for the negligent and/or intentional acts of others, including but not limited to the acts of other Participants or other Providers, that may arise from my (my son's, daughter's or ward's) participation in USSC. This includes any claim for failure to supervise, or the failure to enforce rules, regulations, policies, instructions, laws or codes.

I/WE AGREE to ski and snowboard safely at all times, to conduct myself in a proper manner and in accordance with the Skier Responsibility Code, to comply with the rules and policies of USSC, and to obey all signs and all instructions given by USSC and/or its PROVIDERS.

I/WE AUTHORIZE any person connected with USSC PROVIDERS to administer first aid to me (or my child – under 18), as they deem necessary, and release them for any liability therefore. I authorize medical and surgical care and transportation to a medical facility or hospital for treatment necessary for my well-being, at our expense.

I/WE AGREE that any and all photographs taken of me at any time during, by, or in connections with the USSC may be published by USSC.

I/WE UNDERSTAND that the USSC is NOT AFFILIATED with the municipality of the Town of Uxbridge or the Uxbridge Public Schools in any way.

I/WE UNDERSTAND that ABSOLUTELY NO INVERTED AERIALS OR SOMERSAULTS may be performed while participating in the USSC.
